JOURNAL ENTRY MODIFYING AND RATIFYING CONSENT ORDER

NOW on this 14th day of October, 2016, pursuant to the authority granted to the Kansas State Board of Healing Arts ("Board") by K.S.A. 65-2801, et seq., and, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Consent Order filed on September 14, 2016, in the above-captioned matter, is hereby MODIFIED as follows:

- 1) Paragraph 46 shall read "for a period of at least two (2) years," replacing "for a period of at least five (5) years;"
2) Paragraph 60 shall read "After a period of two (2) years," replacing "After a period of five (5) years;" and
3) Paragraph 60 shall also read "not counted towards reducing the two (2) year timeframe," replacing "not counted towards reducing the five (5) year timeframe."

The Consent Order, as modified above, is ACCEPTED and RATIFIED by the Board. The Board shall maintain jurisdiction over this matter to issue any order(s) deemed necessary and appropriate in the circumstances.


