After reviewing the file, hearing the statements of the parties and being duly advised in the premises, the Board finds as follows:

1. Licensee was originally licensed in the State of Kansas on December 8, 1984 and was issued license no 4-20777.

2. On November 26, 1986, Licensee resigned and surrendered his license to practice medicine and surgery in the State of Kansas.

3. On July 13, 1989, Licensee's license was reinstated by the Board.

4. On May 31, 1990, by Stipulation and Agreement, the Board agreed to accept Licensee's voluntary surrender of license to practice medicine and surgery in the State of Kansas.

5. On July 16, 1997, Licensee filed an application for reinstatement of his medical license.

6. By telephone conversation between Licensee and Executive Director, Licensee requested an appearance before the Board to seek advice and direction on what additional requirements might be necessary in order for the Board to give consideration to Licensee's application for reinstatement.

7. Licensee was notified to appear before the Board in a summary proceeding on Saturday, August 16, 1997, at 1:30 p.m.

8. At its meeting on August 16, 1997, the Board considered the length of time Licensee had been out of the active practice of medicine and found Licensee's application for reinstatement to be incomplete.


