FINAL ORDER GRANTING LICENSURE BY ENDORSEMENT

NOW on this 17th day of June 2011, comes before the Kansas State Board of Healing Arts ("Board") the application of Viorel Raducan, M.D. ("Applicant") for a license to practice medicine and surgery in the State of Kansas, and a request for licensure by endorsement. Licensee appears through counsel, Mark A. Stafford of Holbrook & Osborn, P.A. Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the file, hearing the statements and arguments of Ms. Bryson, hearing the testimony of the Applicant, hearing the statements and arguments of Mr. Stafford, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Applicant submitted to the Board an application for a license to practice medicine and surgery in the State of Kansas and a request for licensure by endorsement. Such application was deemed complete and filed with the Board on May 18, 2011.

2. Licensee's last known mailing address provided to the Board is: **confidential**

3. Applicant completed at least seven (7) years of postgraduate training. However, Applicant did not complete his postgraduate training in an ACGME accredited program.

4. Applicant presently holds active and unrestricted medical licenses in Michigan, Texas and Wisconsin, as well as in Ontario, Canada.

5. Applicant is board-certified in orthopedic surgery by the American Board of Orthopedic Surgery.

6. Applicant has satisfactorily demonstrated that he is qualified to receive a license by endorsement pursuant to K.S.A. 65-2833 based upon his licenses in Michigan, Texas and Wisconsin.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that Applicant is hereby granted a license by endorsement to practice medicine and surgery in Kansas effective June 17, 2011.


