FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 7th day of June, 2003, comes on for conference hearing before the Kansas State Board of Healing Arts ("Board") the Application for Licensure to practice medicine and surgery in the state of Kansas filed by Nusrat B.A. Rajput, M.D. (Applicant").

Charlene K. Abbott, Licensing Administrator, presented information before the Board. Applicant appeared in person *pro se*.

After reviewing the file, hearing the statements of Licensing Administrator, hearing the testimony of Applicant and being duly advised in the premises, the Board finds as follows:

- 1, On or about January 17, 2003, Applicant filed an Application for Licensure to receive a license to practice medicine and surgery in the state of Kansas.
2. As part of the Application, Applicant provided a certified transcript of scores of the Federation Licensing Examination (FLEX) reflecting she took and passed the clinical science portion of the examination in December 1974, but did not pass the basic science and clinical competency portions of the examination at that same sitting.
3. In June 1975, Applicant took and passed the basic science and clinical competency portions of the FLEX, but did not retake the clinical science portion which she had passed in December 1974.

4. When Applicant took and passed the three portions of the FLEX examination, the Board policy was to require passage of all three portions of the examination in one sitting.

5. As part of the Application, Applicant provided proof that she has been licensed in both California and Minnesota; that her licenses in those states have never been subject to disciplinary action; that she has been actively practicing under the licenses issued by California and Minnesota since such licenses were issued.

6. Applicant is certified by the American Board of Pathology and passed the required examinations to receive such certification.


7. In light of the unique circumstances relating to the length of time Applicant has been practicing medicine and surgery, her licensure in the states of California and Minnesota, board certification by the American Board of Pathology, and passage of all three portions of the FLEX was attained in only two sittings, Applicant meets the requirements for endorsement set forth in K.S.A. 65-2833.

IT IS THEREFORE ORDERED that the above findings are made the order of the Board and that Applicant meets the requirements for licensure by endorsement under the provisions of K.S.A. 65-2833 and is eligible for a license to practice medicine and surgery in the state of Kansas

IT IS SO ORDERED.


