NOW this February 19, 2010 the above captioned matter comes before the Board on the respondent's Application for an Institutional License. The petitioner appears in person and by and through Jennifer Bazin of the Law Office of Carol Ruth Bonebrake, P.A. The Board appears by and through Julia Mowers, Associate Litigation Counsel. There are no other appearances.

1. The petitioner is a graduate of the Ziauddin Medical University of Pakistan.
2. The Ziauddin Medical University of Pakistan has been in existence for 14 years and two months which is less than fifteen years.
3. The petitioner has practiced medicine in the United States
4. The Ziauddin Medical University has been recognized by numerous other state licensing agencies.
5. The petitioner requests a waiver of the fifteen year requirement for medical schools and granted a Kansas institutional license.

For good cause shown, the fifteen year requirement is WAIVED. The respondent's Application for an Institutional License is hereby GRANTED.
