FINAL ORDER
(Pursuant to K.S.A. 77-501 et seq.)

Pursuant to the authority granted to the Kansas State Board of Healing Arts (“Board”) by K.S.A. 65-2801 et seq. and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 et seq., the Board hereby enters this Final Order in the above-captioned matter. Members of the Board serving on the Disciplinary Panel for this matter were recused from participation.

WHEREUPON, the Board having the agency record before it, being duly advised in the premises and hearing the statements and arguments of the parties, FINDS and ORDERS as follows:

I. Findings of Fact

1. Ramakrishna Reddy, M.D. (“Applicant”) 3838 Dewey Ave, Omaha, NE 68105-1196, submitted an Application for Licensure to Practice Medicine and Surgery (“Application”) in the State of Kansas on or about November 9, 2009. The Application was deemed complete and filed on September 14, 2010.
2. On or about July 19, 2010, Applicant submitted a letter to the Board requesting licensure by endorsement.

3. Applicant currently holds an active license to practice medicine and surgery in the States of California, Illinois, Nebraska, Iowa, and Colorado and an inactive license in the State of Minnesota.

II. Policy Statement

Recognizing that the practice of the healing arts is a privilege granted by legislative authority and is not a natural right of individuals, it is deemed necessary as a matter of policy in the interests of public health, safety and welfare, to provide laws and provisions covering the granting of that privilege and its subsequent use, control and regulation to the end that the public shall be properly protected against unprofessional, improper, unauthorized and unqualified practice of the healing arts and from unprofessional conduct by persons licensed to practice under this act.

III. Conclusions of Law

4. Applicant is eligible for licensure by endorsement by virtue of his active licensure to practice medicine and surgery in the States of California, Illinois, Nebraska, Iowa, and Colorado pursuant to K.S.A. 65-2833.
5. Applicant has not had a license limited, suspended, or revoked or been censured or had other disciplinary action taken against his licenses.

IT IS HEREBY ORDERED BY THE KANSAS STATE BOARD OF HEALING ARTS THAT:

6. Applicant is hereby **GRANTED** licensure by endorsement pursuant to K.S.A. 65-2833.
7. The Board shall maintain jurisdiction over this matter to issue any Order(s) deemed necessary and appropriate.


