FINAL ORDER

NOW THIS 16<sup>TH</sup> day of October, 2009, the above captioned matter comes before the Kansas State Board of Healing Arts on the petition of Adelbert T. Reece, M.D. to terminate Licensee's probation that was entered by the Board on June 16, 2009. The licensee appears by and through James T. Wiglesworth. Board staff appears by and through Lori D. Dougherty, Associate Litigation Counsel. There are no other appearances. The Board, being duly apprised of the premises finds as follows:

1. On June 16, 2009 the Licensee and the Board entered into a Consent Order wherein the Licensee agreed to probation in order to participate in a Prescribing Course conducted by the University of California, San Diego School of Medicine.

2. The Licensee has successfully completed that course.

3. On June 16, 2009 the Licensee and the Board entered into a Consent Order wherein the Licensee agreed to probation in order to participate in a Medical Record Keeping Course conducted by the University of California, San Diego School of Medicine.

4. The Licensee successfully completed that course.

5. Board Staff does not object to the termination of the Licensee's probation.

WHEREFORE, the Licensee's probation based upon the Consent Order entered into with the Board on June 16, 2009 is terminated.

**PLEASE TAKE NOTICE** that this is a final order. A final order is effective upon service. A party to an agency proceeding may seek judicial review of a final order by filing a petition in the District Court as authorized by K.S.A. 77-601, et seq. Reconsideration of a final order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the final order. A copy of any petition for judicial review must be served upon Michael Beezeley, the Board's Chair, at 235 SW Topeka Blvd., Topeka, KS 66603.


