JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about June 8, 2018, Licensee entered into a Consent Order with the Board for concerns regarding repeated instances involving a failure to adhere to the applicable standard of care, conduct likely to harm the public, a pattern of practice which demonstrates a manifest incapacity or incompetence to practice the healing arts, and adequacy of patient record documentation. The Consent Order publicly censured Licensee and required him to write an essay explaining his continued use of prolotherapy and platelet-rich plasma in his practice.

2. The Board record reflects that Licensee has completed all terms of the Consent Order and has no further obligation for compliance with the Consent Order.




