provisions regarding his physical therapy license as set forth in the Consent
Order which Licensee entered into with the Board and was filed on August 25,

The Consent Order was entered as a condition of Licensee being granted
reinstatement of his physical therapy license (Confidential)

In lieu of denial of reinstatement of licensure, Licensee entered into the Consent
Order which, for a period of at least five (5) years, limited Licensee to only
practicing physical therapy in a group setting (Confidential)

Licensee is restored to a full and unrestricted scope of physical therapy practice.


