**ORDER TERMINATING STIPULATION AND AGREEMENT

NOW ON THIS 12<sup>th</sup> day of June, 1999, comes on for Conference Hearing before the Board of Healing Arts ("Board") the request of Jeffrey P. Rhoads, M.D. ("Licensee") that the Stipulation and Agreement and Enforcement Order filed on December 8, 1997, be terminated. Stacy Cook, Litigation Counsel, appeared for the Board. Dr. Rhoads appeared *pro se*.

After examining the files, hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1. A Stipulation and Agreement and Enforcement Order was entered into between Licensee and the Board on December 8, 1997.
2. Licensee has requested termination of the Stipulation and Agreement and Enforcement Order.
3. Notice of Conference Hearing setting this matter for conference hearing at 10:30 a.m. on June 12, 1999 was filed herein on May 6, 1999 and served on Licensee.
4. That after hearing statements of the parties, the Board is satisfied that Licensee has been in compliance with the conditions placed upon his license.

5. Counsel for the Board does not oppose the termination of said Stipulation.

**NOW, THEREFORE,** it is ordered by the Board that the findings above made be and the same are hereby made the order of the Board; that the Stipulation and Agreement and Enforcement Order filed on December 8, 1997 is hereby terminated.


