NOW on this 26<sup>th</sup> day of February 2010, this matter comes before the Kansas Board of Healing Arts (“Board”) regarding Licensee’s payment of costs. Wherefore, the Board finds as follows:

1. On or about November 2, 2001, a Proposed Default Order was issued finding that Licensee had failed to comply with monitoring requirements of a prior Board order; failed to respond to a subpoena; and failed to pay costs in the amount of \$2,675.38 assessed against him in a prior Board action in Docket No. 00-HA00032. Licensee had only paid \$25.00.
2. The Proposed Default Order stated that Licensee’s license should be revoked.
3. On or about November 26, 2001, a Journal Entry was filed in this matter stating that the Proposed Default Order became a Final Order by operation of law on November 20, 2001.
4. On or about November 6, 2009, Licensee made payment in full of the outstanding amount of costs in Docket No. 00-HA00032.
5. Licensee has satisfactorily made payment in full of the costs assessed to him. No further payment is due.
