FINAL ORDER FOLLOWING RECONSIDERATION

NOW, on this 26th day of April, 2003, comes on the request of Ahmed Robbie, M.D. (“Applicant”) for reconsideration of Final Order filed in the above-entitled matter on February 19, 2003. Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (“Board”) presents information to the Board. There are no other appearances.

After reviewing the file and being duly advised in the premises, the Board finds, concludes, and orders as follows:

1. Applicant submitted an Application for Licensure to practice medicine and surgery in the state of Kansas on October 1, 2001.
2. On February 19, 2003, the Board entered a Final Order denying Applicant’s Application for Licensure for want of proof of graduation from a professional college.
3. On March 3, 2003, and within 15 days of the service of the Final Order, Applicant filed with the Board an original diploma and transcripts from Mosul Medical College. These documents have been reviewed by the Licensing Administrator and determined to be authentic.
4. The filing of the original transcripts and diploma with the Board within 15 days of the Final Order filed February 19, 2003, is considered to be a petition for reconsideration and that reconsideration of such Final Order should be granted.


5. By providing an original diploma and transcripts issued to Applicant by Mosul Medical School, Applicant has provided satisfactory proof of his graduation from medical school and Applicant's Application for Licensure is deemed to be complete and a license to practice medicine and surgery should be issued to Applicant without the need to provide a certified Verification of Professional College.

IT IS THEREFORE ORDERED that the Application for Licensure filed by Ahmed Robbie, M.D. is granted and that a license to practice medicine and surgery in the state of Kansas should be issued to Applicant effective April 26, 2003.


