JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER

COMES NOW the Kansas State Board of Healing Arts ("Board"), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 et seq., as amended, and upon due consideration of the agency record, the applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

- 1. On or about December 13, 2017, Licensee entered into a Consent Order with the Board for concerns regarding improper fee splitting, advertising painless treatment, conduct likely to deceive, defraud, or harm the public, adequacy of patient record documentation, and failure to identify the branch of healing arts in which Licensee holds a license. The Consent Order publicly censured Licensee, imposed a fine of \$1,500.00, and required Licensee to attend education on medical record keeping, ethics, and ethical advertising.
2. The Board record reflects that Licensee has completed all terms of the Consent Order and has no further obligation for compliance with the Consent Order.




