JOURNAL ENTRY OF SATISFACTION

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the file and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. Barbara Allen Roecker, R.T. (“Licensee”) has, since approximately August 15, 1987, maintained License No. 16-00064 to engage in the practice of respiratory therapy in the State of Kansas.

2. Licensee’s mailing addresses of record to the Board is: confidential, Ottawa, Kansas 66067. Licensee’s site of practice mailing address of record with the Board is: Ransom Memorial Hospital, 13th and Main, Ottawa, Kansas 66067.

3. On May 17, 2011, Executive Director Selzler Lippert, in accordance with K.S.A. 2010 Supp. 77-514, and as authorized by K.S.A. 2010 Supp. 65-5510, issued a Summary Order suspending Licensee’s license to practice as a respiratory therapist in the State of Kansas for failure to pay an on-line late license renewal fee of \$77.00, as required by K.S.A. 65-5509 and K.A.R. 100-55-4 of the Respiratory Therapy Practice Act and regulations promulgated thereunder.

4. Pursuant to K.S.A. 77-542, the Summary Order notified Licensee that if a written request for hearing was not filed within 15 days following service of the Summary Order, the Summary Order would become effective as a Final Order of the Board upon expiration of the time for requesting a hearing.

5. Pursuant to K.S.A. 2010 Supp. 77-531, the Summary Order was served upon Licensee by mailing a copy of the Summary Order to Licensee at Licensee's two last known addresses of record, via United States Mail, first-class postage prepaid.

6. Pursuant to K.S.A. 77-512, 77-526, and 77-530, the Summary Order became effective as a Final Order on June 6, 2011, and **Licensee's license to practice respiratory therapy in the State of Kansas was thereby suspended.**

7. On or about June 9, 2011, Licensee remitted a money order to the Board in the amount of \$75.00.

8. On or about July 5, 2011, Licensee remitted a money order to the Board in the amount of \$2.00.

9. Licensee has satisfied all requirements of the Final Order and has no further obligation for compliance.

10. The Board shall maintain jurisdiction over this matter to issue any further Order(s) deemed necessary and appropriate.

IT IS THEREFORE ORDERED that Licensee has satisfied all terms and conditions of the Final Order, and that the violations set forth in the Final Order shall be deemed resolved without entry of further order.


