NOW, on this 20th day of February, 2009, the above-entitled matter comes on before the Kansas State Board of Healing Arts (“Board”) for conference hearing on Applicant’s request for waiver of the ten year rule for completing Step 3 of the USMLE. Applicant appears not. Stacy Bond, Associate Litigation Counsel, appears for the Board. There are no other appearances.

WHEREUPON, having the agency record before it, hearing the statements and arguments of counsel and being duly advised in the premises, the Board FINDS and ORDERS as follows:

1. On or about July 16, 2008, Applicant submitted an Application for Kansas Licensure.
2. On or about September 29, 2008, Applicant sent a letter to the Board requesting waiver of the ten (10) year rule for completing Step 3 of the USMLE. The Board accepts this letter as a valid Motion.
3. The Board heard this matter at the regularly scheduled Board meeting on December 5, 2008.
4. At that time, the Board continued the matter until Applicant provided information concerning his activities between 1994 and 1996.
5. The Applicant has since provided the requested information.


6. The Board finds that waiver of the ten (10) year rule for Step 3 of the USMLE is fair, just and equitable in this case and it is waived.

**JOURNAL ENTRY**


