ORDER OF RETROACTIVE REINSTATEMENT OF TEMPORARY PERMIT

NOW on this 27th day of April, 1996, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole in a conference hearing, the request of Paul R. Rosenau (hereinafter "Permittee") for retroactive reinstatement of his second temporary permit

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts. Permittee appears in person *pro se*. Jackie Rawlings appears on behalf of the Physical Therapy Examining Committee.

After reviewing the request and being otherwise duly advised in the premises, the Board finds as follows:

1. Permittee was granted a temporary permit on October 2, 1995, which expired February 15, 1996.
2. On February 29, 1996, Permittee's request for a second temporary permit was received and granted.
3. On March 4, 1996, the Board received Permittee's request for retroactive reinstatement of the second temporary permit to February 15, 1996.

4. The failure of Permittee to timely request a second temporary permit was due to inadvertence and mistake on the part of Permittee.

IT IS THEREFORE BY THE BOARD ORDERED as follows:


A. That the findings here and above made be and the same are made the Order of the Board.

B. That permit number 96-22615 issued to Paul R. Rosenau on February 29, 1996 be retroactively reinstated to February 15, 1996, to reflect that Permittee has continuously held a temporary permit from and since October 2, 1995.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.


