**ORDER TERMINATING STIPULATION AND AGREEMENT
AND ENFORCEMENT ORDER**

NOW ON THIS 8th day of December, 2001, comes on for Conference Hearing before the Board of Healing Arts ("Board") the request of Stanton L. Rosenberg, M.D. ("Licensee") that the Stipulation and Agreement and Enforcement Order filed on June 15, 1998, be terminated. Kelli Benintendi, Associate Counsel, appeared for the Board. T. Bradley Manson, Esq. appeared for Licensee. Licensee did not appear.

After examining the files, hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1. A Stipulation and Agreement and Enforcement Order was entered into between Licensee and the Board on June 15, 1998.
2. A modification to the Stipulation and Agreement and Enforcement Order was filed on August 25, 2000.
2. Licensee has requested termination of the Stipulation and Agreement and Enforcement Order.
3. Notice of Conference Hearing setting this matter for conference hearing at 10:15 a.m. on December 8, 2001 was filed herein on October 26, 2001 and served on Licensee.
