
After examining the files, hearing statements of the Board counsel, hearing statements from the Licensee, and being otherwise duly advised in the premises, the Board finds as follows:


- 1) That , Licensee remained in compliance with the **STIPULATION** and **ENFORCEMENT ORDER** entered into on July, 17, 1989.
- 2) That the **STIPULATION** and **ENFORCEMENT ORDER** entered into July 17, 1989 should be terminated.

NOW, THEREFORE, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board, that the **STIPULATION** and **ENFORCEMENT ORDER** entered into on July 17, 1989 is hereby terminated, that Licensee is released from further compliance with the provisions set forth in the **STIPULATION** and **ENFORCEMENT ORDER** entered into on July 17, 1989 with the Kansas Board of Healing Arts and that any and all restrictions and


limitations imposed on Licensee's license to practice medicine and surgery by the aforementioned **STIPULATION** and **ENFORCEMENT ORDER** and **MODIFICATION** be removed.
