
FINAL ORDER GRANTING WITHDRAWAL OF APPLICATION

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about April 19, 2013, Applicant submitted an application for a post-graduate permit in the State of Kansas. Such application was determined to be complete and filed with the Board on July 22, 2013.
2. On or about July 2013, the Respondent Board filed a Response in Opposition to Applicant’s application.
3. Applicant’s application was scheduled for a conference hearing on August 9, 2013. Upon Applicant’s request, the conference hearing was continued to December 13, 2013.
4. On November 20, 2013, Applicant requested that her application be withdrawn.
5. The Respondent Board did not oppose the request for withdrawal.
6. The Board did not consider the merits of either Applicant’s application or the Response in Opposition.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that without making any findings of fact or conclusions of law on the merits of this matter, Applicant's request to withdraw her application for a post-graduate permit in the State of Kansas is hereby granted.
