Wherefore, the Board finds as follows:


1. On or about December 17, 2009, a Final Order was entered in this matter which required, in part, for Licensee pay costs in the amount of \$5,733.73, due and payable by March 17, 2010.
2. On or about January 4, 2010, Licensee petitioned the Board for reconsideration of the Final Order, specifically the assessment of costs.
3. On or about April 1, 2010, a new Final Order was filed with the Board which amended the amount of the costs assessed to \$4,627.98, to be paid in twelve (12) monthly installments.
4. On or about April 4, 2011, Licensee paid the \$4,627.98 costs in full.
5. Licensee has satisfactorily met all requirements of the Final Order related to payment of costs and has no further obligation for compliance with financial obligations.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements to pay costs contained in the Final Order filed on April 1, 2010.
