
JOURNAL ENTRY

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, in accordance with the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon consideration of the file, and being otherwise duly advised in the premises, makes the following determinations:


1. Angela L. Sader, R.T. (“Licensee”) has, since approximately February 12, 2001, maintained License No. 16-02675 to engage in the practice of respiratory therapy in the State of Kansas.
2. On September 1, 2010, Licensee entered into a Consent Order with the Board. Under the terms of the Consent Order, Licensee was required to attend and successfully complete, by September 15, 2010, the “S.O.A.P. Charting” continuing education course for record documentation, offered through Respiratory Care Educational Consulting Services, Inc. Licensee was further required to provide proof of such successful completion to the Board by September 15, 2010.
3. On or about June 28, 2010, Licensee submitted proof of successful completion of the “S.O.A.P Charting” continuing education course required by the Consent Order.

IT IS THEREFORE ORDERED that Licensee has satisfied all terms and conditions of the Consent Order filed on September 1, 2010, and that the allegations contained in the Consent Order shall be deemed resolved without entry of further order.
