**FINAL ORDER**

NOW on this 15th day of February, 1997, this matter comes on for conference hearing upon the request of Robert E. Sager, M.D. (hereinafter "Applicant") to approve his qualifications for licensure to practice medicine and surgery, pursuant to K.S.A. 65-2801 *et. seq.* There are no other appearances.

Charlene K. Abbott, Licensing Administrator, presents information to the Kansas Board of Healing Arts (hereinafter "Board").

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and order:

1. An application for examination was received from Applicant on December 12, 1996.
2. Notice of Conference Hearing setting this matter for hearing at 11:30 a.m., Saturday, February 15, 1997, was filed herein on January 31, 1997 and served on Applicant on that same date.
3. Applicant has applied for permanent licensure to practice medicine and surgery, attended the Faculty of Medicine, receiving a three-year medical degree, and holds a license in Ontario, Canada.

4. Applicant received his M.D. degree from the Faculty of Medicine, Toronto, Ontario, having attended the institution from September 1967 through June 1970.

5. The Board concludes that Applicant has met the educational requirements for licensure.

IT IS, THEREFORE, ORDERED that Applicant be placed on the list for approval of licensure to practice medicine and surgery, such list to be presented and acted upon by the Board at the April, 1997 Board meeting.

This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.
