JOURNAL ENTRY APPROVING PRACTICE SUPERVISOR

NOW on this 8th day of January, 2013, comes on for consideration before the Kansas State Board of Healing Arts (“Board”), Licensee’s request for approval of a practice supervisor. In accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and the applicable statutes and otherwise being duly advised in the premises, Board President Kimberly J. Templeton, M.D. makes the following determinations:

1. On September 2, 2011, the Board issued a Final Order Terminating Suspension and Imposing Limitation on License (“Final Order”). The provisions of the Final Order in their entirety are incorporated herein by reference.
2. The provisions of the Final Order includes a requirement for Licensee to have a supervising physician.
3. On or about January 2, 2013, the Board received a request for approval from Ralph Bharati, M.D. for him to serve as Licensee’s supervisors pursuant to the provisions of the Final Order. The request was accompanied by Dr. Bharati’s curriculum vitae.
4. The request for approval was reviewed by Board President, Kimberly Templeton, M.D., in place of the previous Board’s designee, who is no longer a member of the Board.

5. Upon such review by Dr. Templeton, it was determined that Dr. Bharati should be approved to fulfill the supervision requirements set forth in the Final Order.

IT IS THEREFORE ORDERED that Ralph Bharati, M.D. is approved to serve as Licensee's practice supervisor pursuant to the provisions of the Final Order Terminating Suspension and Imposing Limitation on License.


