FINAL ORDER GRANTING WITHDRAWAL OF APPLICATION

NOW on this 11th day of October, 2013, comes before the Kansas State Board of Healing Arts (“Board”) the application of Jose Jesus Sanchez Chavez (“Applicant”) for an active license to practice medicine and surgery in the State of Kansas. Applicant appears in person and *pro se*. Jessica Bryson, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by K.S.A. 65-2801 *et seq.* and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, the evidence presented, and hearing the statements and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. On or about February 14, 2013, Jose Jesus Sanchez Chavez (“Applicant”) submitted an application to the Board for active licensure by endorsement pursuant to K.S.A. 65-2833.
2. Applicant sought licensure by endorsement because he did not attend an approved school of medicine and does not have two (2) years of post-graduate education which was approved by or is equivalent to ACGME accredited post-graduate education.
3. Applicant has held a Colorado medical license since March 14, 2012.

4. Applicant does not appear to have been in the active practice of medicine in the State of Colorado since receiving his license.

5. Applicant also holds an active license in Florida with a limitation that restricts Applicant to practice in a teaching institute for one (1) year under indirect supervision of a Florida-licensed allopathic physician.

6. Applicant has not been in the active practice of medicine in the State of Florida since obtaining his Florida license.


7. The Board concludes that Applicant does not meet the requirements for licensure by endorsement under K.S.A. 65-2833 because he has not been in the active practice of medicine in the State of Colorado, and has only a limited, conditional license to practice in the State of Florida.

8. In lieu of denial, Applicant requests the Board grant withdrawal of his application.

9. The Board accepts such withdrawal of Applicant's application.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that Applicant's request to withdraw his application for active licensure by endorsement to practice chiropractic in the State of Kansas is hereby GRANTED.


