SUMMARY GRANTING SECOND TEMPORARY REGISTRATION

NOW, on this 16th day of April, 1994, this matter comes on for Summary Proceedings at the request of Michelle I. Savage, R.T. (hereafter "registrant") for a second temporary registration pursuant to K.S.A. 65-5508(e).

Charlene K. Abbott, Licensing Administrator, appears on behalf of the Kansas State Board of Healing Arts (hereafter "Board"). There are no other appearances.

After examining the file, hearing statements of the Licensing Administrator and being otherwise duly advised in the premises, the Board makes the following findings of fact, conclusions of law and order:

- 1) A request for a second temporary registration was filed by registrant on April 13, 1994.
- 2) Registrant has applied for permanent registration as a Respiratory Therapist but has not passed an examination approved by the Board as required by K.A.S. 65-5506.

3) Registrant was granted a temporary registration number 9300466 on March 24, 1993 which expired on March 24, 1994.

4) Pursuant to K.S.A. 65-5508(e) no more than one temporary registration will be permitted to any one person without the majority approval of the members of the Board.

5) Upon payment of the appropriate fee, registrant should be granted a second temporary registration until results from the examination required for permanent registration to be administered in July, 1994, become available.

IT IS THEREFORE ORDERED as follows:

a) Upon payment of the appropriate fee, a second temporary registration be granted to registrant until the Board receives the results from the examination required for permanent registration as a respiratory therapist to be administered in July, 1994.

b) In the event registrant fails to pass the examination to be administered in July, 1994, the second temporary registration hereby granted to registrant should expire and be cancelled on the date of the next regularly scheduled meeting of the Board following the date the failure becomes available to the Board.

c) This is a Summary Order and either party is entitled to an administrative review of this order if written request is received in the Board office within 5 days of service of this order upon the parties.

IT IS SO ORDERED.
