**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 17th day of October, 1998, this matter comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533, the request of Laura Ann Saviski, P.A. (hereafter "Registrant") for retroactive reinstatement of registration. Licensee appears pro se.

After hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1. Registrant was a registered Physician's Assistant, having been issued registration number 15-00501 on <sup>April 27, 1996</sup> ~~February 29, 1996~~. This registration was subsequently cancelled February 1, 1998 for non-renewal as provided by K.S.A. 65-2896.
2. Registrant did not receive the notice of renewal from her business office.
3. Registrant received a missing requirement letter from the Board dated July 10, 1998 indicating the requirements needed for reinstatement.

4. Registrant continued to work as a Physician's Assistant during the period between February 1 and September 25, 1998.

5. Registrant applied for and received reinstatement of her registration on September 25, 1998.

**IT IS THEREFORE BY THE BOARD ORDERED** as follows:

A. That the findings here and above made be and the same are made the Order of the Board.

B. That Registration number 15-00501 issued to Registrant which was cancelled on February 1, 1998 and reinstated on September 25, 1998 be retroactively reinstated to February 1, 1998 and that the records of the Board be amended to reflect that Registrant has continuously held a current registration from and since February 29, 1996.

C. This is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

**IT IS SO ORDERED.**
