JOURNAL ENTRY

NOW, on this 30th day of November, 1993, comes Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") and states as follows:

1. On February 27, 1992, LaDona Marie Schmidt, M.D. (hereafter "Licensee") submitted an Application for License by Endorsement to practice medicine and surgery in the State of Kansas.

2. On April 8, 1992, Licensee was granted License number 4-23959 to practice medicine and surgery in the State of Kansas subject to a Stipulation and Agreement and Enforcement Order entered into between the Board and Licensee which had been previously executed and filed in the Board office.

3. That pursuant to said Stipulation and Agreement and Enforcement Order, Licensee agreed to limit her practice under her license to those activities which would be involved in her post-graduate training program and to not engage in the private practice of medicine and surgery.

4. Licensee has now provided proof to the Board that she has received a full and unrestricted license to practice medicine and surgery in the State of Oklahoma.

5. Based upon Licensee's compliance with the terms and conditions of the Stipulation and Agreement and Enforcement Order and by virtue of the terms of said document, Licensee should be released from any obligation to limit her practice of medicine and surgery to a post-graduate training program, that the Stipulation and Agreement and Enforcement Order filed in the Board office on March 25, 1992 should be hereafter of no further force or effect and that Licensee's license 4-23959 should hereafter be without any restrictions whatsoever.
