FINAL ORDER

NOW ON THIS Twenty Sixth Day of April 2003, comes before the Board the application of Jeffory Schofield, D.C. for a license to practice chiropractic. Applicant appears in person. Kelli J. Benintendi, Associate Counsel, appears for the Board.

After hearing the statements of the parties, and having considered all information Applicant has provided to the Board, the Board finds, concludes and orders as follows:

1. The material facts are not disputed. Applicant graduated from Palmer College of Chiropractic in November 1985. He practiced chiropractic in the State of Arizona following graduation and until October 1991. He has not practiced chiropractic since that time.
2. While practicing in Arizona, the Arizona Board of Chiropractic Examiners informally admonished Applicant by a letter dated December 20, 1990, ordering him to cease performing face lifts, a professional service that is outside the scope of chiropractic. Applicant allowed his Arizona license to lapse in 1995.
3. The Board finds that Applicant is not professionally competent to engage in the active practice of chiropractic in the State of Kansas, and concludes that his application for a license should be denied.

IT IS, THEREFORE, ORDERED that the application of Jeffory Schofield, D.C., for a

license to practice chiropractic is denied.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service. A party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court as authorized by K.S.A. 77-610, et seq. Reconsideration of the Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within 30 days following service of the Final Order. A copy of any petition for judicial review must be served upon the Board's executive director at 235 S. Topeka Blvd., Topeka, KS 66603.
