FINAL ORDER FOLLOWING CONFERENCE HEARING

NOW, on this 15th day of October, 1994, comes on for conference proceedings the request of Kelly J. Schrage (hereafter "Applicant") to grant a second temporary registration pursuant to K.S.A. 65-5508.

Applicant does not appear. Charlene K. Abbott, Licensing Administrator, appears on behalf of the Board. There are no other appearances.

After reviewing the files and being duly advised in the premises, the Kansas State Board of Healing Arts (hereafter "Board") makes the following findings of facts, conclusions of law and order:

1. A request for a second temporary registration was received from Applicant on September 20, 1994 to practice as an respiratory therapist in the State of Kansas.

2. A Notice of Conference Hearing setting this matter for hearing at 1:15 p.m. on October 15, 1994 was filed herein on September 30, 1994 and served on Applicant on that same date.

3. Applicant has applied for permanent registration as a respiratory therapist, but has not passed an examination required

and approved by the Board for registration as a respiratory therapist pursuant to K.S.A. 65-5506.

4. Applicant was granted a temporary registration on February 26, 1993 which expired on February 26, 1994.

5. Pursuant to K.S.A. 65-5508(e) no more than one such temporary registration shall be permitted to any one person without the majority approval of the members of the Board.

6. Applicant should be granted a second temporary registration effective October 15, 1994 and to expire October 15, 1995.

IT IS THEREFORE ORDERED that a second temporary registration for the purposes of holding oneself out as a respiratory therapist be issued to Applicant effective from October 15, 1994 and to expire on October 15, 1995 upon payment of the required fee for such second temporary registration.

IT IS FURTHER ORDERED that this is a Final Order and is effective upon service upon the parties. Any party may, within 15 days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.

IT IS SO ORDERED.
