ORDER TERMINATING JOURNAL ENTRY OF STIPULATION
AND AGREEMENT AND ORDER

NOW, on this 10th day of February, 2001, comes on for Conference Hearing before the Board of Healing Arts ("Board") the request of Gregory P. Schroff, M.D. ("Licensee") that the Journal Entry of Stipulation and Agreement and Order filed on May 7, 1998, be terminated. Kelli Benintendi, Associate Counsel, appeared for the Board. Licensee appeared in person, *pro se*.

After examining the files, hearing statements of the parties and being otherwise duly advised in the premises, the Board finds as follows:

1. A Journal Entry of Stipulation and Agreement and Order was entered into between Licensee and the Board and filed on May 7, 1998.
2. The Board is satisfied that Licensee has met the terms of the Stipulation and the conditions placed upon his license and as such, termination prior to the expiration of the five-year period of the Stipulation's limitations is appropriate.
3. The limitations contained in paragraph 10(a)(i) of the Stipulation should be removed from Licensee's license.

4. The Journal Entry of Stipulation and Agreement and Order filed on May 7, 1998, should be terminated and the limitations contained therein be removed from Licensee's license to practice medicine and surgery.

NOW, THEREFORE, it is ordered by the Board that the findings hereinabove made be and the same are hereby made the order of the Board and that the Journal Entry of Stipulation and Agreement and Order filed on May 7, 1998, is hereby terminated.


