**ORDER DENYING MODIFICATION OF STIPULATION**

NOW on this 22nd day of June, 1996, comes on for conference proceedings before the Kansas State Board of Healing Arts (hereafter "Board") the request of Charles E. Scott, P.A. (hereafter "Registrant") for modification of the Stipulation and Agreement and Enforcement Order entered into on December 12, 1995. Disciplinary Counsel Kevin K. LaChance appears for the Board. Registrant appears in person.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board makes the following findings of fact, conclusions of law and orders:

1. A Stipulation and Agreement and Enforcement Order was entered into between Registrant and the Board on December 12, 1995. Said Stipulation was modified pursuant to Order Granting Modification of Stipulation filed May 7, 1996.
2. By letter received by the Board on June 17, 1996, Registrant requests the Stipulation be modified to allow for additional employment as a Physician's Assistant for Glenn O. Bair, M.D.
3. The Board may use its discretion to grant or deny any modification to the Stipulation, and modification of Registrant's employment must be approved by the Board.
4. The Board finds that Registrant has not provided sufficient cause to grant his request.

IT IS THEREFORE BY THE BOARD ORDERED as follows:

A. That the findings herein above made be and the same are made the Order of the Board.

B. That Registrant's request for modification of the Stipulation to allow him to practice as a Physician's Assistant for Glenn O. Bair, M.D. is hereby denied.

C. That this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.



**ORDER GRANTING MODIFICATION OF STIPULATION**

NOW on this 27th day of April, 1996, comes on for conference proceedings before the Kansas State Board of Healing Arts (hereafter "Board") the request of Charles E. Scott, P.A. (hereafter "Registrant") that the Stipulation and Agreement and Enforcement Order entered into on December 12, 1995 be modified. Appearing are Disciplinary Counsel Kevin K. LaChance, Registrant, and Judy Janes of the Kansas Medical Society.

After reviewing the file, hearing statements of the parties and being duly advised in the premises, the Board finds that the Stipulation should be modified as follows:

1. All findings of fact, conclusions of law and terms and conditions as reflected in said Stipulation are adopted herein and remain unchanged except as may be specifically set forth below.
2. Paragraph 10, subparagraph (d) on pages 3 and 4 of the Stipulation should be modified to read as follows:

"Registrant agrees his ability to practice as a physician's assistant and his registration as a physician's assistant are limited to performing services under the direction and supervision of his responsible physician, Camille Heeb, M.D., or any licensed physician designated to provide direction and supervision within the scope of his employment by her. With the exception of Thursday afternoons, the responsible or designated physician shall be physically present at the same location at all times Registrant is providing services as a physician's assistant. On Thursday afternoons, Registrant may provide services as a physician's assistant without the physical presence of the responsible or designated physician, provided that Dr. Heeb is available by telephone, and another licensed family practice physician is available to provide assistance or supervision."


