## FINAL ORDER TERMINATING MONITORING

NOW, on this $2^{\text {nd }}$ day of December 2011, comes before the Kansas State Board of Healing Arts ("Board") the petition of Trey Shandy, O.T. ("Licensee") for termination of monitoring imposed under the terms of Consent Order filed on September 23, 2010 in Docket No. 10-HA00031. Licensee appears pro se. Stacy Bond, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, et seq., and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, et seq., the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of occupational therapy in the State of Kansas, License No. 17-02700, and has been so licensed since approximately December 3, 2010.
2. On or about September 23, 2010, Licensee entered into a Consent Order with the Board as a condition to being granted licensure confidential confidential
3. On or about September 22, 2011, Licensee petitioned the Board to lift the practice monitoring terms imposed upon Licensee by the Consent Order.
4. The Board finds that Licensee has satisfactorily met all requirements of the Consent Order and should have no further obligation for compliance.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS, that Licensee has satisfied requirements of the Consent Order and that Licensee's petition to terminate the monitoring imposed by the Consent Order is hereby granted.
