FINAL ORDER TERMINATING MONITORING

NOW, on this 2nd day of December 2011, comes before the Kansas State Board of Healing Arts (“Board”) the petition of Trey Shandy, O.T. (“Licensee”) for termination of monitoring imposed under the terms of Consent Order filed on September 23, 2010 in Docket No. 10-HA00031. Licensee appears *pro se*. Stacy Bond, Associate Litigation Counsel, appears on behalf of the Respondent Board.

Pursuant to the authority granted to the Board by the Kansas Healing Arts Act, K.S.A. 65-2801, *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501, *et seq.*, the Board hereby enters this Final Order following a conference hearing in the above-captioned matter. After reviewing the file, hearing the testimony and arguments of the parties, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:

1. Licensee is licensed to engage in the practice of occupational therapy in the State of Kansas, License No. 17-02700, and has been so licensed since approximately December 3, 2010.

2. On or about September 23, 2010, Licensee entered into a Consent Order with the Board as a condition to being granted licensure



4. On or about September 22, 2011, Licensee petitioned the Board to lift the practice monitoring terms imposed upon Licensee by the Consent Order.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service, and service of a Final Order is complete upon mailing. Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order.
