## ORDER OF RETROACTIVE REINSTATEMENT OF LICENSE

NOW, on this 15<sup>th</sup> day of February, 2003, comes on for consideration before the Kansas State Board of Healing Arts ("Board"), sitting as a whole as presiding officer in conference proceedings pursuant to K.S.A. 77-533, the request of Yolanda Shields, M.D. ("Licensee") for retroactive reinstatement of license. Charlene K. Abbott, Licensing Administrator, presented information to the Board. There are no other appearances.

After hearing statements from the Licensing Administrator, reviewing the file and being duly advised in the premises, the Board makes the following findings and orders:

- 1. Licensee was originally granted license number 04-28385 to actively practice medicine and surgery in the state of Kansas on August 14, 1999.
  - 2. Licensee's license was canceled for nonrenewal on August 1, 2002.
- 3. On October 24, 2002, Licensee applied for reinstatement of her license and her license was reinstated as exempt on January 30, 2003.
- 4. On January 29, 2003, Licensee filed a request that her license be retroactively reinstated effective August 1, 2002.
- 5. Licensee has provided proof that she had professional liability insurance in effect in compliance with Kansas law from August 1, 2002 through October 22, 2002, had met the continuing education requirements and was otherwise eligible to renew her license on an active status prior to its cancellation on August 1, 2002.

6. It was due to a misunderstanding and inadvertence that Licensee allowed her license to be canceled on August 1, 2002, due to nonrenewal.

7. That Licensee's license should be retroactively reinstated to August 1, 2002, and such

license should be placed on active status designation from and after August 1, 2002 through October

22, 2002, after which is should be placed on exempt status designation.

IT IS THEREFORE ORDERED that the license of Licensee be retroactively reinstated to August 1, 2002, and that the records of the Board be modified to reflect that Licensee held an active license from and after August 1, 2002 through October 22, 2002, and that thereafter Licensee's

license was exempt.

IT IS SO ORDERED.
