**NOW ON THIS** 24<sup>th</sup> day of October, 2008, the above-entitled matter comes on before John (Jack) Confer, Acting Executive Direction of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Acting Executive Director makes the following determinations.


1. On September 24, 2008, the Acting Executive Director issued a Summary Order publicly censuring the license of Margrethe A. Shoemaker, M.D. to practice as a medical doctor for failure to furnish to the board, its investigators or representatives any information requested by the board. The Summary Order further ordered that if the information was not supplied within 15 days that Licensee's license to practice medicine and surgery would be suspended until the information was provided.

2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would be come effective as a final order of the Board upon expiration of the time for requesting a hearing.

3. No hearing has been requested by any party nor has Licensee provided the requested information; therefore the Summary Order became effective as a final order on October 14, 2008 and Licensee's license to practice medicine and surgery in the state of Kansas is Suspended.


