## ORDER VACATING EX PARTE EMERGENCY SUSPENSION AND IMPOSING EMERGENCY LIMITATION ON LICENSE

NOW, on this 17th day of May, 2013, this matter comes before Presiding Officer John F. Settich, Ph.D. pursuant to K.S.A. 65-2838(c) of the Kansas Healing Arts Act and in accordance with K.S.A. 77-536 of the Kansas Administrative Procedure Act. Wherefore, the Presiding Officer *sua sponte* makes the following findings, conclusions and order:

- 1. On or about May 8, 2013, Petitioner filed a Petition seeking discipline against Licensee's license to practice medicine and surgery in Kansas. On the same date, Petitioner also filed a Motion for *Ex Parte* Emergency Order of Suspension and for Emergency Proceedings and a Motion for an Order Compelling an Evaluation Pursuant to K.S.A. 65-2836(i).
- 2. The Petition and the Motion for *Ex Parte* Emergency Order of Suspension and for Emergency Proceedings generally alleged that Licensee had the inability to safely practice due to Confidential and that Licensee had engaged in inappropriate sexual behavior and actions toward one female patient and similarly violated professional boundaries to a lesser degree with a another female patient. The Motion for *Ex Parte* Emergency Order of Suspension and for Emergency Proceedings further alleged that Licensee's continuation in practice during the pendency of proceedings on the Petition constituted an imminent threat to patient safety and requested a suspension of licensure pursuant to K.S.A. 65-2838(c).

3. The Motion for Ex Parte Emergency Order of Suspension and for Emergency

Proceedings was supported by an affidavit from a Board investigator detailing his observations

of and conversations with Licensee and Confidential

Confidential

4. On or about May 8, 2013, Petitioner also submitted a proposed Ex Parte

Emergency Order of Suspension for consideration by the Presiding Officer.

5. On or about May 10, 2013, Licensee's counsel filed a Response in Opposition to

Petitioner's Motion for Ex Parte Emergency Order of Suspension and for Emergency

Proceedings. The Response in Opposition set forth Licensee's objection to the emergency

suspension based on arguments that there was no emergency or imminent danger due to the

length of time which has passed since Licensee's alleged behavior with the female patients.

Licensee further argued that a suspension exceeded the scope allowed by K.S.A. 77-536(b),

which, in part, requires an agency to take "only such action as is necessary: (1) to prevent or

avoid the immediate danger to the public health, safety or welfare . . . "

6. After consideration of all the pleadings filed, on May 13, 2013, the Presiding

Officer issued the Ex Parte Emergency Order of Suspension which had been proposed by

Petitioner.

ORDER VACATING EX PARTE EMERGENCY SUSPENSION AND IMPOSING EMERGENCY LIMITATION

7. On or about May 15, 2013, Licensee filed a Petition to Stay Agency Action which

requested a stay of the emergency suspension pending judicial review which restated Licensee's

arguments against the emergency suspension. The Petition for Stay also requested

disqualification of the Presiding Officer based on an allegation that inappropriate ex parte

communications occurred between counsel for Petitioner and the Presiding Officer. Based on a

clarification about the timing of when the pleadings and the proposed Ex Parte Emergency Order

of Suspension were presented to the Presiding Officer, counsel for Licensee has since withdrawn

the allegations of inappropriate ex parte communications and the request for disqualification of

the Presiding Officer.

8. The Presiding Officer concludes that the allegations regarding Licensee's

behavior with two female patients and Confidential

supported by the exhibits

offered by Petitioner, evidence an imminent threat to the safety of female patients warranting

emergency action by the agency. Nevertheless, upon further consideration of the arguments

raised regarding the appropriateness of the ex parte emergency suspension in Licensee's

previously filed Response in Opposition to Petitioner's Motion for Ex Parte Emergency Order of

Suspension and for Emergency Proceedings and Licensee's Petition for Stay, the Presiding

Officer concludes that based on the evidence presently available, a limitation prohibiting

Licensee from evaluating and treating female patients will suffice to address the immediate

danger posed by Licensee's continuation in practice.

9. In making such determination, the Presiding Officer also considers that

Licensee's alleged misconduct has only been with female patients and that a basis Confidential

Confidential

has not yet been put into evidence.

ORDER VACATING EX PARTE EMERGENCY SUSPENSION AND IMPOSING EMERGENCY LIMITATION

10. The Presiding Officer concludes that the Ex Parte Emergency Order of

Suspension should be vacated and in its place, an emergency limitation should be imposed on

Licensee's license that prohibits Licensee from performing any evaluation and treatment of

female patients.

11. The Presiding Officer will consider the presentation of additional evidence at the

hearing scheduled for Tuesday, May 21, 2013, in order to determine if the limitation remains

emergently warranted or whether a lesser or more severe action is necessary.

The Motion for Confidential 12.

Pursuant to K.S.A. 65-2836(i)

and Licensee's Response in Opposition thereto will also be heard at the hearing scheduled for

Tuesday, May 21, 2013.

IT IS THEREFORE ORDERED that the emergency suspension of Licensee's license

is VACATED.

IT IS FURTHER ORDERED that Licensee's license is hereby emergently LIMITED to

prohibit Licensee from performing any evaluation and treatment of female patients.

IT IS SO ORDERED this 17th day of May, 2013.
