NOW, on this 13<sup>th</sup> day of Sept., 2010, the above-entitled matter comes on before Kathleen Selzler Lippert, Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Executive Director makes the following determinations.

1. On April 14, 2010, a Summary Order was filed in the above captioned manner which found that Licensee had violated K.S.A. 65-2912 by failing to pay the license/certificate reinstatement fee as provided for in K.S.A. 65-2910.

2. The Summary Order provided that Licensee's license/certificate was suspended until such time as the reinstatement fee of \$80 and the return check fee of \$30 was paid.

3. On May 6, 2010, a Final Order was filed suspended Licensee's license/certificate for failing to pay the license/certificate reinstatement fee. Licensee's license to practice was suspended effective May 3, 2010.

4. On September 13, 2010, licensee paid the \$80 license/certificate reinstatement fee and the \$30 return check fee as provided for in the Summary Order.

5. Licensee has fully satisfied the requirements set forth in the Summary Order filed April 14, 2010, therefore the Suspension of License imposed by the Summary Order filed is lifted effective September 13, 2010, and no further action is required.


