**JOURNAL ENTRY TERMINATING EMERGENCY
ORDER OF TEMPORARY LIMITATION**

On April 11, 2019, this matter comes before the Presiding Officer, pursuant to the notice of hearing filed on March 27, 2019, for the hearing on whether the emergency limitation of the license of Jeff M. Sloyer, M.D. (“Licensee”), filed on March 27, 2019 (“Emergency Order”), should remain in effect during the pendency of the proceedings arising from the Petition filed in this matter.

Based on the evidence provided at the hearing, and in light of the current agency record, the presiding officer **terminates the Emergency Order, effectively immediately.** The presiding officer finds that the totality of the evidence thus far presented does not demonstrate cause to believe that Licensee’s continuation in practice would constitute an imminent danger to the public health and safety.

A supplemental Journal Entry will be subsequently entered containing further discussion of the findings and rationale of the presiding officer arising from the April 11, 2019 hearing.

IT IS, THEREFORE, ORDERED that the Emergency Order affecting the license of Jeff M. Sloyer, M.D., Kansas License No. 04-29872, is hereby **IMMEDIATELY TERMINATED.**
