COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about June 25, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Physician Assistant Licensure Act, K.S.A. 65-28a01, *et seq.* The Consent Order required Licensee attend and successfully complete the continuing education course for Effective and Efficient Methods of Documenting Patient Care, and to provide the Board documentation evidencing completion of the same by October 4, 2013.

2. On or about October 23, 2013, Licensee submitted documentation evidencing completion of “Patient Care Documentation Seminar” presented by the Center for Personalized Education for Physicians.

3. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on June 25, 2013.


