**ORDER OF RETROACTIVE MODIFICATION TO LICENSE STATUS**

NOW, on this 9th day of October, 1993, comes on for consideration before the Kansas State Board of Healing Arts (hereafter "Board"), sitting as a whole as Presiding Officer in a conference proceeding pursuant to the provisions of K.S.A. 77-533 through 77-535, the request of Jon Stephen Smith, D.C. (hereafter "Licensee") for retroactive modification of license status.

Charlene K. Abbott, Licensing Administrator, appears on behalf of the Board. Licensee did not appear. There are no other appearances.

After reviewing the request and being otherwise duly advised in the premises, the following findings are made:

1. Licensee was originally licensed to practice chiropractic in the State of Kansas on June 28, 1979.
2. On August 20, 1993, Licensee applied to have the status of his license changed from active to exempt and said status was so changed effective September 9, 1993.
3. That Licensee, (confidential) has not practiced chiropractic in the State of Kansas outside of that allowed under an exempt license from and since March 15, 1993.

4. That by inadvertence, (confidential) Licensee failed to make proper application to change his license status from active to exempt until August 20, 1993.

**IT IS THEREFORE BY THE BOARD ORDERED AS FOLLOWS:**

A. That the findings here and above made be and the same are made the order of the Board.

B. The status of the license of the Licensee, Jon Stephen Smith, D.C., to practice chiropractic in the State of Kansas should be retroactively modified to reflect that Licensee's license was placed on exempt status as of March 15, 1993, and such exempt status has continued from and since said date.

C. This is a Final Order and is effective upon service on the parties. Any party may, within 15 days after service, filed a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite for seeking administrative or judicial review.


