## JOURNAL ENTRY

- 1. On August 11, 2008, the Acting Executive Director, on behalf of the Board, issued a Summary Order which it was determined that Judith K Smith, RT should be assessed a fine in the amount of \$250.00, payable within 30 days of the effective date of the order, for failure to respond to the Board's request by the June 30, 2008 deadline.
- 2. The Summary Order contained a notice that a written request for hearing could be filed within 15 days following service, but if no hearing is requested, the Summary Order would become effective as a final order of the Board upon expiration of the time for requesting a hearing.
- 3. The Summary Order was deposited in the United States mail, first class postage prepaid to the mailing address provided by Licensee: 218 Ninth, Ogden, KS 66517.
- 4. On August 14, 2008, the Summary Order was returned by the United States Postal Services as not deliverable as addressed, unable to forward.

- 5. Pursuant to K.S.A. 65-28, 126 Licensee has a duty to notify the Board in writing within 30 days of any change in Licensee address.
- 6. On August 14, 2008, Board staff left a message requesting a current address at the latest telephone number provided by the Licensee.
  - 7. Licensee has not provided a change of address or return call.
- 8. No hearing has been requested by any party and; therefore, the Summary Order became effective on September 2, 2008; and as stated in the Summary Order a civil fine of \$250.00 is payable within 30 days of the effective date.
