**JOURNAL ENTRY OF SATISFACTION VACATING SUSPENSION OF  
LICENSE**

NOW, on this 7<sup>th</sup> day of October 2008, the above-entitled matter comes on before Jack Confer, Acting Executive Director of the Kansas State Board of Healing Arts. After reviewing the file and being duly advised in the premises, the Acting Executive Director makes the following determinations.

1. On August 11, 2008, A Summary Order was filed in Docket No. 09-HA00027 which found that Judith K Smith, RT (Licensee) had violated K.S.A. 65-2836(r), assessed a civil penalty of \$250.00 and required that documented proof of compliance with continuing education requirements be submitted within fifteen (15) days of issuance of the Summary Order. The Summary Order stated that failure to comply with the terms of the Order would result in the suspension of the license to practice respiratory therapy in Kansas. Licensee failed to comply with the terms of the order.


2. On September 29, 2008, the license of Licensee was suspended for failure to provide documented evidence of the minimum continuing education hours.

3. On October 6, 2008, licensee paid the \$250 fee and provided documented proof of completion of the minimum of 24 hours of continuing education, double the deficient hours.

4. Licensee has fully satisfied the requirements set forth in the Summary Order filed August 11, 2008 by paying the \$250 civil penalty and providing documentation of completion of continuing education credits; therefore the Suspension of License imposed by the Summary Order filed September 29, 2008 is lifted, and no further action is required.


