**FINAL ORDER**

**NOW**, on this 25th day of April, 1998, comes before the Kansas State Board of Healing Arts (hereinafter "Board") sitting as a whole, the application of Cynthia Wright Smith-Burton, D.C. (hereinafter "Applicant") for license by endorsement to practice chiropractic in the state of Kansas.

Charlene Abbott, Licensing Administrator, presented information before the Board. Applicant appeared *pro se*.

After reviewing the file, hearing statements and being otherwise duly advised in the premises, the Board finds as follows:

1. Applicant has been licensed in the state of Illinois and currently holds a license to practice chiropractic in the state of Missouri.
2. Applicant's license to practice chiropractic was issued by the state of Illinois on August 28, 1986 based upon Illinois state examinations which are at least

equal in quality to the examinations required for licensure in the state of Kansas.

3. Applicant has been actively engaged in the practice of chiropractic since receiving a license to practice in Illinois.

4. Applicant meets the requirements for license by endorsement pursuant to K.S.A. 65-2833.


**IT IS THEREFORE ORDERED** that Applicant has met the requirements for license by endorsement to practice chiropractic in the state of Kansas and consideration of application will be placed on the agenda for final approval at the Board Meeting to be held June 13, 1998.


