JOURNAL ENTRY ON APPROVAL OF CONSENT ORDER  
WITH MODIFICATIONS


On October 12, 2018, the parties appeared before the Kansas Board of Healing Arts (Board) for a conference hearing on the approval of the Consent Order in the above captioned matter. Meredith Snyder, M.D. (Licensee) appeared in person and through counsel, Cynthia Sheppard. Courtney Manly, Associate Litigation Counsel, appeared on behalf of the Board. The parties submitted a proposed Consent Order, executed by Applicant on August 14, 2018, for the Board's review and approval. Upon review of the proposed consent order, and taking into consideration of the statements and testimony received at the hearing, the Board approved the Consent Order with the following changes as agreed by all parties:

1. Paragraph 46 is deleted. It is unnecessary since a temporary license was not issued.
2. Paragraph 60 is deleted and replaced with the following requirement:
  - a. "Applicant will complete a list of all patients who were seen by Applicant in the preceding month to send to CCI on the 28th of each month. From this list, CCI may choose to review all of the patient charts submitted, or at the minimum, choose at least ten (10) patient charts to review Applicant's documentation and adherence to RHT's protocols."

**THEREFORE**, the Consent Order executed by Licensee on August 14, 2018, and submitted to the Board for review and approval at the October 12, 2018 Board meeting, is hereby **APPROVED** with the agreed **MODIFICATIONS** ordered herein.


