INTERIM ORDER

NOW ON THIS 23rd Day of April 2005, this matter comes on for hearing.

Applicant appears in person. Kelli J. Benintendi appears for the Board.

Having the agency record before it, the Board finds, concludes and orders as follows:

1. Applicant is licensed to practice medicine and surgery in the State of Oklahoma. On June 5, 2003, the Oklahoma State Board of Medical Licensure and Supervision filed an order based upon stipulated facts. Applicant acknowledged that he had engaged in a sexual relationship with a patient beginning in December 2001 and continuing through August 2002. The order suspended Applicant's Oklahoma license.

2. The Oklahoma board reinstated Applicant's license on August 7, 2003. The license was to be on probation for a period of five years, commencing on May 29, 2003. The terms of probation include monitoring and participation in a program for recovery.

3. The Board finds that the application should be granted on the condition that Applicant successfully and fully completes the monitoring and participation in a recovery program as required by the Oklahoma board, and upon the condition that Applicant **Confidential**

He does agree that he will continue compliance with the Oklahoma board's requirements.

4. The Board finds that Applicant should be granted a temporary permit so that Applicant and Confidential have sufficient time to discuss and agree to a


Confidential The temporary permit shall expire on June 11, 2005, at which time Applicant shall come before the Board for completion of this proceeding.

IT IS, THEREFORE, ORDERED that Applicant shall be granted a temporary permit to practice medicine and surgery in the State of Kansas, and that the permit shall be valid through June 11, 2005.

IT IS FURTHER ORDERED that this matter shall come before the Board on June 11, 2005 at 11:00 a.m. for completion of the proceeding. No further notice will be given.
