SUMMARY ORDER DENYING APPLICATION FOR CERTIFICATION

NOW, on this 20th day of November, 1997, this matter comes before Lawrence T. Buening, Jr., Executive Director of the Kansas State Board of Healing Arts (hereafter "Board") in summary proceedings pursuant to K.S.A. 77-537.

After reviewing the agency record and being duly advised in the premises, following findings of fact, conclusions of law and orders are made for and on behalf of the Board.

1) On or about November 6, 1997, Renata Katarzyna Soltys (hereafter "Applicant") filed an Application For Certification As A Physical Therapist Assistant to practice physical therapy in the State of Kansas.

2) In response to item number 14 of the application, Certificate of Physical Therapist Assistant School, Applicant provided the Board with a Document Request Form indicating the physical therapy institution from which Applicant graduated as being Medyczne Studium Zawodowe Nr 4, Krakow, Poland, August 1, 1997.

3) Pursuant to K.S.A. 1996 Supp. 65-2906(b)(2), Applicant must have successfully completed the academic requirements of an educational program in physical therapy

approved by the board which is appropriate for the certification of the applicant. Medyczne Studium Zawodowe Nr 4, in Krakow, Poland is not a Board-approved educational program of physical therapy.

IT IS THEREFORE ORDERED AND DECREED for and on behalf of the Board as follows:

a) That, pursuant to K.S.A. 1996 Supp. 65-2906, Applicant has not successfully met the requirements provided for in this act for certification as a physical therapist assistant in the State of Kansas.

b) Applicant's Application For Certification As A Physical Therapist Assistant received by the Board on November 6, 1997 be **DENIED**.

c) This is a Summary Order and either party is entitled to a review if a written request is received in the Board office within 15 days of service of the Order upon the parties. If no request is received, this Order will become immediately effective.

IT IS SO ORDERED.
