FINAL ORDER

NOW, on this 4th day of December, 2009, the above-entitled matter comes on before the Kansas State Board of Healing Arts (“Board”) for conference hearing on Respondent’s Request for Termination of Suspension. WHEREUPON, having the agency record before it, hearing the statements and arguments of counsel and being duly advised in the premises, the Board FINDS and ORDERS as follows:

1. By Final Order filed October 22, 2008, Respondent’s license to practice respiratory therapy in Kansas was suspended for one (1) year.
2. After one (1) year, the Final Order granted Respondent leave to request that the suspension be terminated “upon demonstrating to the Board that he is safe to practice (confidential)


IT IS THEREFORE ORDERED that the suspension of Respondent's license to practice respiratory therapy in Kansas is terminated, (confidential)
