FINAL ORDER

NOW on this 12th day of December, 2014, comes on for conference hearing before the Kansas State Board of Healing Arts (“Board”) the Petition for discipline filed against the physical therapist assistant certificate of Anna Starks, PTA (“Licensee”). Jane Weiler, Associate Litigation Counsel, appears on behalf of the Petitioner Board. Licensee appears in person and *pro se*.

Pursuant to the authority granted to the Board by the Physical Therapy Practice Act, K.S.A. 65-2901 *et seq.*, and in accordance with the provisions of the Kansas Administrative Procedure Act K.S.A. 77-501 *et seq.*, the Board hereby enters this Final Order in the above-captioned matter. After reviewing the agency record, hearing the statements and arguments of the parties, receiving exhibits into evidence, and being otherwise duly advised in the premises, the Board makes the following findings, conclusions and order:


1. Licensee is presently licensed to practice as a physical therapist assistant in the State of Kansas, having been issued Certificate No. 14-02765 on or about August 12, 2014.
2. The Board finds that Licensee does not dispute the material facts alleged in the Petition.
3. Based on the facts shown, the Board concludes that Licensee’s acts and conduct constitute violations of the Physical Therapy Practice Act as alleged in the Petition.

4. Licensee advises the Board that she is agreeable to extending the terms of her Consent Order for a period of three (3) years in lieu of disciplinary action against her certificate.

IT IS THEREFORE ORDERED, BY THE KANSAS STATE BOARD OF HEALING ARTS that based on the agreement of Licensee, the terms of Licensee's Consent Order shall be extended for a period of no less than three (3) years from the date this Final Order is filed with the Board.

IT IS FURTHER ORDERED that after a period of at least three (3) years, Licensee may request termination of the Consent Order on her certificate to practice as a physical therapist assistant. For any period of time that Licensee is not actively practicing as a physical therapist assistant in Kansas, the requirements shall remain in effect, but will be tolled and not counted towards reducing the three (3) year timeframe.

PLEASE TAKE NOTICE that this is a Final Order. A Final Order is effective upon service, and service of a Final Order is complete upon mailing. Pursuant to K.S.A. 77-529, Licensee may petition the Board for Reconsideration of a Final Order within fifteen (15) days following service of the final order. Additionally, a party to an agency proceeding may seek judicial review of a Final Order by filing a petition in the District Court, as authorized by K.S.A. 77-601, *et seq.* Reconsideration of a Final Order is not a prerequisite to judicial review. A petition for judicial review is not timely unless filed within **30 days** following service of the Final Order. 
