**JOURNAL ENTRY OF SATISFACTION OF CONSENT ORDER**

COMES NOW the Kansas State Board of Healing Arts (“Board”), by and through its Executive Director, Kathleen Selzler Lippert, a duly authorized representative of the Board, in accordance with the provisions of the Kansas Administrative Procedure Act, K.S.A. 77-501 *et seq.*, as amended, and upon due consideration of the agency record and applicable statutes and regulations, and being otherwise duly advised in the premises, makes the following determinations:

1. On or about August 19, 2013, Licensee entered into a Consent Order with the Board for alleged violations of the Kansas Physician Assistant Licensure Act, K.S.A. 65-28a01, *et seq.* The Consent Order required Licensee attend and successfully complete a continuing education course for proper prescribing practices and a course for financial counseling, and to provide the Board documentation evidencing completion of the same by January 31, 2014. Further, the prescription writing practices of Licensee to be monitored for three (3) months, with the Board-approved prescription monitor to submit monthly reports to the Board related to these reviews. Additionally, Licensee was required to pay costs in the amount of \$682.50, and Licensee was to remit payment to the Board by September 15, 2013.

2. On or about September 16, 2013, Licensee remitted full payment of costs in the amount of \$682.50, to the Kansas State Board of Healing Arts.

3. On or about October 4, 2013, November 6, 2013, and December 11, 2013, Richard Toon, M.D., Licensee's Board-approved prescription practice monitor, submitted to the Board the monthly reports regarding Licensee's prescription writing practices. Dr. Toon opined that Licensee prescribed medications within the standard of care, and did not identify any problems or concerns with Licensee's prescription writing practices.

4. On or about January 3, 2014, Licensee submitted documentation evidencing completion of "Medical Ethics and Prescribing" presented by the Medical Foundation of Alabama, which Licensee completed on November 22-24, 2013.

5. On or about January 3, 2014, Licensee submitted documentation evidencing completion of "Counseling Services" offered by the Consumer Credit Counseling Service, Inc., which Licensee completed on November 18, 2013.

6. Licensee has satisfactorily met all requirements of the Consent Order and has no further obligation for compliance.

**IT IS THEREFORE ORDERED** that Licensee is hereby discharged from all requirements of the Consent Order filed on August 19, 2013.


