**FINAL ORDER FOLLOWING CONFERENCE HEARING**

NOW, on this 13th day of June, 1998, comes on for conference proceedings before the Kansas State Board of Healing Arts (hereinafter "Board") sitting as a whole, the application of Ron Sterling, M.D. (hereinafter "Applicant") for license by endorsement to practice medicine and surgery in the state of Kansas.

Charlene Abbott, Licensing Administrator, presented information before the Board. Applicant appeared *pro se*. George Dyck, M.D., also appears at the request of the Board.

After reviewing the file, hearing statements and being otherwise duly advised in the premises, the Board finds as follows:

1. That Applicant orally requested that his Application for Endorsement be withdrawn and the Board finds that Applicant's request should be granted.

2. Applicant may apply for a postgraduate permit to engage in a geriatric psychiatric postgraduate fellowship for a period of one year at the University of Kansas Medical Center School of Medicine, Wichita, Kansas and upon a finding by Board staff

that such application is fully completed, a postgraduate permit should be issued to Applicant.

**IT IS THEREFORE ORDERED** that Applicant's application for licensure be withdrawn.

**IS FURTHER ORDERED** that this is a Final Order and is effective upon service upon the parties. Any party may, within fifteen (15) days after service, file a Petition for Reconsideration. The filing of a Petition for Reconsideration is not a prerequisite to seeking administrative or judicial review.

**IT IS SO ORDERED.**


